The President extended a welcome to the new Fellows and Associates who were attending their first meeting of the Society after attaining their present ranks. Also taking part in the welcome were Vice-Presidents Pearce Shepherd and C. A. Spoerl.

The President announced the death of Mr. Henry H. Jackson, a former President of the American Institute of Actuaries. Mr. M. A. Laird read the obituary as printed in this number of the *Transactions*. The Society stood for a moment in silent respect to the memory of Mr. Jackson.

A telegram was handed to the President informing him of the death of Mr. Douglas P. Morris, a Fellow of the Society. The Society stood for a moment in silent respect to the memory of Mr. Morris. His obituary is printed in this number of the *Transactions*.

The Secretary-Treasurer presented the following summary of the business transacted by the Board of Governors since the last meeting of the Society:

1. The Board received the report of the Advisory Committee on the relationship between examination results and success as an actuary.
2. The Board approved and endorsed, subject to certain limitations, the request of Professor Carl H. Fischer of the University of Michigan, and a Fellow of the Society, made in connection with his study of the selection and education of actuaries.
3. The Board recommended that the Advisory Committee give consideration to the development of material regarding a career as an actuary which would especially be suited for distribution among high school seniors.
4. The Board received a report that 42 Fellows of the Society had indicated an intention to attend the Centenary of the Faculty of Actuaries in Scotland in 1956.

5. The following Fellows of the Institute of Actuaries were admitted as Associates of the Society:

6. As of April 30, 1955, the membership of the Society consisted of 847 Fellows and 652 Associates, or a total of 1,499.

The Society proceeded to the presentation of papers printed in this number of the *Transactions*.

The Society next discussed informally Topic I with Vice-President Pearce Shepherd presiding. The meeting adjourned for lunch at 12:50 P.M.

The afternoon session was called to order at 2:15 P.M. by Mr. M. E. Davis, Chairman of the Committee on New Recording Means and Computing Devices. The program consisted of a motion picture on Electronic Machines and a panel presentation by the members of this committee of their forthcoming report. This report will be printed by the Society. Following several questions directed to the panel, the session adjourned at 4:45 P.M.

On Friday, June 3, the meeting was called to order by Vice-President C. A. Spoerl at 9:30 A.M. Topics II, III, and IV, were discussed informally. The meeting adjourned at 11:35 A.M.

The Smaller Company Forum, under the Chairmanship of Mr. G. E. Cannon, was called to order by Mr. Cannon at 1:30 P.M.
