## MINUTES OF THE REGIONAL MEETING

of the

## SOCIETY OF ACTUARIES

HELD AT THE WALDORF-ASTORIA HOTEL NEW YORK, NEW YORK APRIL 5-6, 1971

The meeting was called to order by the President, Mr. E. B. Lancaster, on Monday, April 5, 1971, at 9:15 A.M. The following is a summary of the attendance at the meeting:

The President welcomed Mr. William K. Paynter, Executive Vice-President of the Institute of Life Insurance; Dr. John D. Hogan, Vice-President—Planning and Development, Nationwide Insurance Company; Mr. J. T. Ranadive, F.I.A., President of the Actuarial Society of India, and Chief Actuary of the Life Insurance Corporation of India; and Mr. Price Gaines, Jr., Editor of Cost Facts on Life Insurance (The National Underwriter Company, Cincinnati, Ohio, 1969).

The President recognized two long-time Fellows of the Society—Mr. J. E. Hoskins, a Past President of the Society, and Mr. Marcus Gunn, Consulting Actuary, Sacramento, California.

The President extended a welcome to the new Fellows and Associates who were attending their first meeting of the Society after attaining their present ranks.

The President then introduced Mr. Walter W. Steffen as moderator of the panel session on "The Actuary's Responsibility to his Various Publics." Panel members were Messrs. Samuel Eckler, Ernest J. Moorhead, and William K. Paynter. Following the panel presentation, the President thanked the panelists.

At 10:45 A.M. there was a brief recess, after which the meeting reassembled in four concurrent sessions. Concurrent Session A, "Actuarial

After a brief recess, the meeting reconvened in general session.

The President recognized Mr. H. Raymond Strong, President of the American Academy of Actuaries.

The President advised that the Society had received word of the deaths of eight members since the last meeting: Robert N. Griswold, John T. Hoyt, Mrs. Estella Fisher King, John W. Lincoln, John B. St. John, and Robert N. Stabler, Fellows; and Harold M. Horne and Clair C. Kirkpatrick, Associates. The members observed a moment of silence in respect of the memory of these members. Obituaries are printed in this volume of the *Transactions*.

The President introduced the authors of two papers, Mr. Arthur W. Anderson, author of "A New Look at Gain and Loss Analysis," and Mr. John A. Fibiger, coauthor of "Actuarial Functions as Expected Values" (the other coauthor is Stephen G. Kellison).

Following this, Mr. Joseph C. Sibigtroth gave a brief report on the results of the study of Mortality on Large Amounts of Insurance, which had not been completed in time for inclusion in the 1969 Reports number of the Transactions; Mr. Morton D. Miller gave a report on the Monday morning concurrent session on the "Elections by Mail" topic; Mr. Robert C. Winters reviewed recent developments in the study of life insurance company financial reporting methods by the American Institute of Certified Public Accountants and the Joint Actuarial Committee on Financial Reporting.

After thanking all the participants and planners involved, the President adjourned the meeting at 12:15 P.M.
