PREFACE

The Committee's report consists of four sections, as follows:

- I. Group Life Insurance Mortality
- II. Group Weekly Indemnity Insurance
- III. Group Long-Term Disability Insurance
- IV. Exposure and Claim Study—Sample of Group Hospital and Surgical Expense Insurance

Section I adds the experience by number of lives under Group Life insurance policies for calendar years 1965-69 to the experience previously reported in the 1965 Reports. This report presents experience by industry using the Standard Industrial Classification (SIC) code format published by the United States government in place of the previously used Society of Actuaries code format.

Sections II and III are the latest reports of the continuing studies of these benefits. Section II includes an analysis by female per cent. Section III has been expanded to include experience for plans with a twelvementh elimination period, an analysis of experience for nonjumbo experience units insuring less than 5,000 lives, and a table of illustrative disabled life annuity values.

Section IV presents the second report of the continuing study of claim frequencies, charges, and claim costs for a sample of basic, hospital, and surgical expense insurance plans. This section shows combined data with respect to experience during calendar years 1967–69.
