John Archer, ASA 1950. Born Yarmouth, England, February 23, 1913. Died London, England, March 29, 1986. Graduated Reading University, 1931. Served in Royal Artillery in World War II. Fellow, Institute of Actuaries, 1947. He was employed at Unilever Company and retired in the 1970s.

Charles Howard Barnaby, FSA 1959. Born Indianapolis, Indiana, September 1, 1932. Died Richardson, Texas, July 9, 1995. Graduated Amherst, 1954. His career was primarily in consulting, with Lewis & Ellis in his last years.

Coleman Bloomfield, FSA 1954. Born Winnipeg, Canada, July 2, 1926. Died St. Paul, Minnesota, June 17, 1995. Graduated University of Manitoba, 1947. Most of his career was at Minnesota Mutual Life, from which he retired; at his death he was Chairman of the Board.

Paul Turgeon Bourdeau, FSA 1964. Born Concord, New Hampshire, June 7, 1932. Died Pasadena, California, August 14, 1996. Graduated Pennsylvania State University, 1953. His insurance career was at Travelers and Phoenix Mutual until he moved to California in 1983 as President of Beneficial Standard Life. He was President of his own consulting firm in his last few years before disability retirement in 1993. He is survived by his wife, Patricia L. Shapiro, FSA.

Darl Brooks, ASA 1990. Born Wooster, Ohio, November 15, 1964. Died, March 30, 1996. Graduated Miami (Ohio) University. He was employed at Nationwide Insurance until his death in an automobile accident.

Frank Arthur Brooks, FSA 1956. Born Providence, Rhode Island, June 14, 1927. Died Dade City, Florida, March 6, 1996. Graduated Yale, 1949. His entire career except for service in World War II and Korean War was at Mutual Benefit Life, New Jersey till retirement in 1986 from the post of Vice-President.

Winfield Charles Burley, ASA 1961. Born Buffalo, New York, July 27, 1924. Died Woodbridge, Virginia, August 13, 1996. Graduated University of Buffalo, 1949 after a tour of duty in the U.S. Army in World War II. After life insurance employment in New York and New Jersey, he joined Palisades Life in 1968, becoming its President. He then served the National Health & Welfare Retirement System, moving then to the National Office of Internal Revenue Service becoming Chief of its Pension Actuarial Branch until his disability retirement in 1985.

Richard A. Burr, FSA 1978. Born Richmond, Virginia, April 13, 1944. Died Morristown, New Jersey, October 28, 1996. Graduated Trinity College, Hartford, 1965. After employment at Mutual Life of New York, he entered consulting at several locations and was in his own firm in Morristown when he died.

Lachlan Campbell, FSA 1933. Born Argyllshire, Scotland, January 8, 1903. Died Knowlton, Quebec, July 9, 1996. Graduated from Edinburgh University, 1925. His entire North American career was with Sun Life Assurance Company 1928-1968, retiring as Senior Vice-President. He was a member of Society's Board of Governors, 1962-1965.

Leslie A. Cannon, FSA 1935. Born Winnipeg, Manitoba, December 13, 1911. Died Winnipeg, Manitoba, January 1, 1996. Graduated University of Manitoba, 1931. Entire career was at Great-West Life Assurance Company, 1931-1977, retiring as Director, Individual Products.

George Bertel Carlson, ASA 1951. Born Brooklyn, New York, February 25, 1913. Died Mount Arlington, New Jersey, June 23, 1995. Attended Cooper Union 1934-1937. He was President of his own consulting firm, New York City.

James Wilfrid Chambers, FSA 1945. Born Allenford, Ontario, September 22, 1909. Died Waterloo, Ontario, May 21, 1996. Graduated University of Western Ontario, 1932. His entire career was at Mutual Life of Canada, retiring in 1974 as Vice-President & Chief Actuary. One of his survivors is his son, Morris W. Chambers, FSA.

George David Chester, FSA 1948. Born Warehouse Point, Connecticut, January 24, 1910. Died West Hartford, Connecticut, June 30, 1996. Graduated Trinity College, Hartford, 1929. He started his career at Travelers. The last 12 years were at Phoenix Mutual, retiring in 1972 as Vice-President.

Clarence Manton Eddy, FSA 1926. Born Providence, Rhode Island, 1901. Died West Hartford, Connecticut, December 21, 1996. Graduated from Brown University, 1922. His entire career was at Connecticut General Life, 1922-1972, retiring as Senior Vice President.

Donald Roy Edwards, FSA 1965. Born Chicago, Illinois, September 4, 1929. Died West Lafayette, Indiana, September 1996. Graduated Iowa State Teachers College, 1951. Career was Guarantee Mutual Life, and then Lafayette Life until retirement in 1994 from the post of Executive Vice-President, Secretary & Treasurer.

Philip Francis Finnegan, FSA 1948. Born Marion, Ohio, December 17, 1919. Died Chatham, New Jersey, November 8, 1996. Graduated Kent State University, 1941. Except for Army Air Force service in World War II, his entire career was at Prudential Insurance Company, retiring in 1984 as Vice-President & Assistant Actuary.

Harold Romine Greenlee, FSA 1962. Born New York City, January 9, 1932. Died Phillipsburg, New Jersey, March 31, 1996. Graduated Harvard, 1953. His entire career was at Prudential Insurance Company until his retirement in 1993 from the post of Vice-President & Assistant Actuary.

Edwin Ernest Hill, ASA 1949. Born Withes, Wisconsin, May 18, 1914. Died Sierra Madre, California, 1996. Graduated Minnesota, 1938. Much of his career was in consulting with Milliman & Robertson, retired c. 1980.

Benjamin Thomas Holmes, FSA 1930. Born Toronto, Canada, May 6, 1905. Died Toronto, December 2, 1996. Mr. Holmes' obituary is printed in the *North American Actuarial Journal*, January 1997 (Vol. 1, No. 1, p. 111).

Charles Henry Jones, ASA 1930. Born Charleston, South Carolina, Dec. 16, 1904. Died Flower Mound, Texas, December 20, 1996. Graduated from The Citadel, Charleston, 1925. Entire career was at Metropolitan Life, 1927-1970, retiring as Assistant Actuary.

George Duane Kitchen, ASA 1958. Born Yuba City, California, December 1, 1926. Died Northridge, California, April 25, 1996. Graduated University of California (Los Angeles), 1951. His career was in consulting, finally as head of his own firm until his retirement in 1992.

Edwin Beattie Lancaster, FSA 1949. Born LeMars, Iowa, August 1, 1916. Died Mount Kisco, New York, October 24, 1996. Mr. Lancaster's obituary is printed in the *North American Actuarial Journal*, January 1997 (Vol. 1, No. 1, p. 111).

Edward Abraham Lew, FSA 1934. Born Warsaw, Poland, February 23, 1909. Died Punta Gorda, Florida, June 20, 1996. Mr. Lew's obituary is printed in the *North American Actuarial Journal*, January 1997 (Vol. 1, No. 1, p. 111).

Donald Collins MacTavish, FSA 1957. Born Kitchener, Ontario, March 23, 1925. Died Waterloo, Ontario, September 1996. Graduated McMaster University, 1949. His entire career was with Mutual Life of Canada until retiring in 1990 from the post of Vice-President & Chief Actuary. His father, Archie Neil MacTavish, was an Actuarial Society member.

Neil Thomas Patrick William Malley, ASA 1974. Born Malaysia, March 17, 1941. Died Wellington, New Zealand, February 2, 1996. Education in England; qualified as Fellow of the Institute of Actuaries in 1971. Most of his career was in New Zealand where after both insurance and consulting work he was appointed Government Actuary and held that post at the time of his death.

Richard Lee Maurer, FSA 1978. Born Springfield, Illinois, August 12, 1946. Died Nashville, Tennessee, April 16, 1996. Graduated University of Iowa, 1968. His first employment was at National Life & Accident Insurance Company, Nashville, after which until his death he was a data processing specialist in Nashville.

Richard Jay Mellman, FSA 1948. Born Cleveland, Ohio, February 4, 1919. Died Short Hills, New Jersey, May 9, 1996. Graduated Harvard, 1939. His entire career, 1940–1983, interrupted only by U.S. Army Service in World War II, was at Prudential Insurance Company, retiring as Vice-President & Actuary.

Nathan Abraham Moscovitch, FSA 1955. Born St. Boniface, Manitoba, October 30, 1913. Died Evanston, Illinois, April 29, 1996. Graduated University of Manitoba, 1933. He was in consulting throughout his career, from 1960 till retirement in 1987 with Wolfman & Moscovitch, Chicago.

John Phelps, FSA 1948. Born Indianapolis, Indiana, August 15, 1917. Died on vacation in Italy, May 16, 1996. Graduated Michigan, 1938. From 1938 to 1967, he was at Lincoln National Life, leaving as Senior Vice-President. Then he was President of British-American Insurance Company, and Director of Munich-American Insurance Company. He retired in 1980. His father was a Fellow of the American Institute of Actuaries.

Archibald Moffat Price, ASA 1934. Born Deloraine, Manitoba, November 5, 1907. Died Southbury, Connecticut, June 7, 1996. Graduated from Manitoba University, 1928. His career was in consulting until his retirement in 1975.

Owen Athol Reed, FSA 1962. Born Auckland, New Zealand, September 11, 1930. Died Oakville, Ontario, October 28, 1996. Graduated Auckland University, 1950. His entire career was at Sun Life of Canada from 1955 until retirement in 1995 from the post of Vice-President & Actuary.

Robert G. Robotka, ASA 1960. Born Racine, Wisconsin, August 10, 1931. Died Willcox, Arizona, December 6, 1995. Graduated University of Wisconsin, 1953. He was employed first in life insurance, then from 1967 till retirement in 1987, in consulting.

Irving G. Roth, FSA 1935. Born New York City, September 13, 1909. Died Hollywood, Florida, November 15, 1995. Attended College of City of New York, 1926-1928. His entire career was with Metropolitan Life, 1928-1974, retiring as Vice-President.

Jack L. Rowland, ASA 1953. Born Pittsburgh, Pennsylvania, August 14, 1922. Died Anderson, South Carolina, January 28, 1996. Graduated University of Pittsburgh, 1947. His entire career was at Mutual Benefit Life, New Jersey, retiring in 1983 from the post of 2nd Vice-President, Underwriting.

Pierre Roy, FSA 1956. Born Quebec, Canada, April 15, 1924. Died Montreal, Quebec, September 1996. Graduated Laval University, 1945. Career was at Industrial Life, Quebec until 1954, then in consulting, and finally with the Government of Quebec until his retirement in 1985.

Walter James Rupert, FSA 1941. Born Madoc, Ontario, August 15, 1903. Died Stillwater, Minnesota, May 6, 1996. Graduated McMaster University, 1925. After several years at Sun Life of Canada, he moved to Minnesota Mutual Life in 1944, retiring in 1968 as Chairman of the Board.

Carl Wayne Solenberger, FSA 1944. Born Underwood, North Dakota, August 21, 1910. Died Springfield, Illinois, September 1996. Graduated University of North Dakota, 1933. His career since 1946 was at Franklin Life in Springfield, retiring in 1975 as Actuarial Vice-President.

Robert Carl Steiner, FSA 1968. Born New York City, July 30, 1939. Died Montclair, New Jersey, March 1, 1996. Graduated from Brooklyn College, 1960. His entire career was in consulting, his final years as head of Furlin & Steiner of Montclair.

Graham Clark Thompson, ASA 1937. Born Gloversville, New York, June 22, 1910. Died Punta Gorda, Florida, September 28, 1996. Graduated Union College, Schenectady, 1931. Was at Metropolitan Life, 1932-1948, then moved to Security Mutual Life, Binghamton, retiring in 1970 as Senior Vice-President & Actuary.

Dennis Raye Tobleman, ASA 1977. Born Galveston, Texas, July 1, 1952. Died Richardson, Texas, May 9, 1996. Graduated University of Texas (Austin), 1973. Early employment was at American National Insurance Company. Turning to consulting, he soon became a partner of Maurer & Tobleman but returned to American National where he was at his death.

Schuyler Warren Tompson, FSA 1966. Born Glen Ridge, New Jersey, January 9, 1930. Died Albuquerque, New Mexico, June 10, 1996. Graduated Dartmouth, 1951. After U.S. Navy service in the Korean War, his career was mainly in consulting. He retired in 1993 after employment as Chief Actuary at Blue Cross/Blue Shield of New Mexico.

David Thomson Warner, FSA 1971. Born York, Pennsylvania, February 4, 1930. Died Radnor, Pennsylvania, October 23, 1996. Graduated Princeton, 1952. Principal career was with Provident Mutual Life, Philadelphia. He retired in 1989 and was employed at Pennsylvania Life & Health Guarantee Association when he died.

Charles Barry Hurst Watson, FSA 1959. Born Toronto, Canada, June 30, 1934. Died McLean, Virginia, September 23, 1996. Mr. Watson's obituary is printed in the *North American Actuarial Journal*, January 1997 (Vol. 1, No. 1, p. 112).

Edward Charles Zeiger, FSA 1942. Born Bayonne, New Jersey, April 17, 1913. Died Madison, Connecticut, September 21, 1996. Graduated Stevens Institute of Technology, 1933. His entire career was at Guardian Life, New York City, retiring in 1978 as Vice-President & Actuary.
