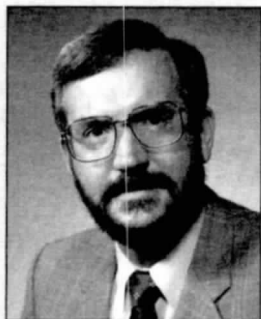

Concerned about ethics?

Starting in 1990, those completing the SOA examinations will be required to attend the Fellowship Admissions Course (FAC) before the Fellowship designation will be conferred. The two topics to be covered in the course are (1) integrating of the examination syllabus and (2) professional ethics.

The Society has established working committees under the supervision of a steering committee to develop the course content. The working committee on the professional ethics content of the FAC is seeking your assistance.

In order to help prepare future Fellows for situations that they may encounter in their careers, we are asking the SOA membership to submit descriptions of situations raising questions of professional ethics in the performance of actuarial responsibilities. Submissions must not reveal confidential information, identify by name or title any other persons, nor identify the company or companies involved. It is not necessary that you personally have been faced with the ethical questions, but we are seeking actual situations with which you are familiar. Topics might include conflicts of interest, conflicts with management, operating outside one's area of expertise, whistle-blowing, relations with other actuaries, contingent fees, disclosure, SOA/AAA/CIA guidelines, etc.

Submissions should be sent to Linden Cole, Education Actuary, at the SOA office. Again, it is important not to reveal confidential information, the names of companies, nor other persons involved in the event.
