## Abstract

This paper gives a unified approach to modern credibility models by using the theory of estimating functions. Previous credibility models, such as Bulhmann-Straub model, Jewell's hierarchical model, Hachemeister's regression model can all be obtained by this method. New models to incorporate higher-order moments and changing conditional variance are suggested.
