ABSTRACT

This paper derives expressions for the moments of the distribution of the option payoff in a Black Scholes economy. These results are of intertest from a purely statistical viewpoint. They may also be of interest given the current importance of value at risk calculations. We also derive formulae for the moments of barrier options and provide numerical examples.
