Mr. Pearce Shepherd, newly elected President of the Society, expressed his appreciation for the honor which had been conferred on him.

The President delivered his Presidential Address as printed in this number of the *Transactions*.

The President introduced as special guests Mr. Henri de G. Laurie, F.F.A., of Cape Town, South Africa, Dr. Dan M. McGill of the Wharton School of Finance and Commerce, University of Pennsylvania, Philadelphia, and Mr. Kenneth A. Usherwood, F.I.A., of London, England.

The President referred to the loss of two of our members by death since the last meeting: Mr. Robertson G. Hunter, a Fellow of the Society, and Mr. Clifford H. Folz, an Associate. The members stood for a moment in silent respect to the memory of the deceased members. Obituaries are printed in this number of the *Transactions*.

The President reported that the Triennial Prize for the three-year period just ended had been awarded to Mr. E. Allen Arnold for his paper, "The Analysis of Approximate Valuation Methods." Congratulations were extended to Mr. Arnold.

The Secretary-Treasurer presented the following summary of the business transacted by the Board of Governors since the last meeting of the Society:

1. The Education and Examination Committee have had a very busy year. It is interesting to note that there was a substantial increase in

the numbers sitting for Parts 1 and 2, suggesting that the Society's public relations activities are bearing fruit.

A change in the examination syllabus has been made effective in 1959 with respect to Parts 3 and 4. An announcement was made of this change earlier this year. The syllabus and general regulations for the 1959 examinations are set forth in the *Requirements for Admission* booklet dated August 1, 1958. Certain modifications have been made in the section regarding limitations on writing examinations.

A major revision has been made in respect to the study material for Part 5 in connection with construction of tables and for Part 6 in respect of gross premiums and agency problems.

2. The Committee on Mortality and Morbidity among Lives Individually Insured reports that the work in connection with the build and blood pressure study has progressed to the point where definite plans have been formulated for a detailed report to be published probably in the late spring of 1959 in the form of two sizable volumes, one presenting the analysis and summary of the results and the other detailed tables.
3. The Board approved the following meetings:

5. A committee has been studying the question of draft deferment for actuarial students. It appears doubtful that deferment, other than brief postponement until after the next actuarial examinations, will be granted to Students and Associates. A more detailed report, including the action to be taken where postponement is desired, will be forwarded to the Chief Actuary of each company or organization.
6. As of September 15 the membership of the Society consisted of 1,031 Fellows and 794 Associates, making a total of 1,825.

The Treasurer's report as printed in this number of the *Transactions* was presented in summary form.

Mr. William J. November, Chairman of the Committee on Disability

and Double Indemnity, reported that the Committee is presently preparing its report on the intercompany double indemnity investigation that it has been conducting and that they expect the report will be included in the next Reports Number of the *Transactions*. Mr. November commented briefly on some of the results of the investigation and distributed some of the tables that will appear in the report.

The Society proceeded to the presentation and discussion of the papers as printed in this number of the *Transactions*.

A welcome was extended to the new Fellows and Associates who were attending their first meeting of the Society after attaining their present ranks. Diplomas were presented to those who completed their Fellowship last May. Copies of the *Guides to Professional Conduct* were distributed to the new Associates.

The meeting adjourned for lunch at 12:30 P.M.

The afternoon session was called to order at 1:30 P.M. The presentation and discussion of papers was continued with President Rood presiding.

The afternoon session adjourned at 3:40 P.M.

At 9:30 A.M. Friday, October 3, the meeting reassembled in three separate groups meeting simultaneously for informal discussion of subjects of special interest. These groups were as follows:

On Friday afternoon the meeting was called to order at 2:00 o'clock by Vice-President Dennis N. Wartens. The Society discussed informally Topic IV with Mr. Gilbert W. Fitzhugh, Chairman of the Committee to Review Membership Requirements, introducing the subject.

On behalf of the Society, Mr. Walter Klem presented a silver tray to the President. President Rood responded expressing his appreciation for all the assistance he had received.

The Society discussed informally section 2 of Topic VII and Topics II and III with Vice-Presidents Norman M. Hughes and Dennis N. Wartens presiding in turn. The afternoon session adjourned at 4:50 P.M.

On Saturday morning, October 4, the meeting was called to order at 9:00 o'clock with Vice-Presidents N. M. Hughes and D. N. Wartens presiding in turn. Mr. James T. Phillips, Chairman of the Industry Actuarial Advisory Committee to the N.A.I.C. Subcommittee on Deficiency Re-

serves and Mortality Table Review, presented as summary of the Committee's final report. He was assisted by various members of his Committee in the presentation. The Society then proceeded to the informal discussion of the first section of Topic VII.

The Society discussed informally Topics I, V, VI and the remaining sections of Topic VII.

On behalf of the Society, Vice-President Warters expressed appreciation to the host companies for their generous hospitality. In closing the meeting Mr. Warters thanked the authors of the papers and all those who entered into the various discussions.

The meeting adjourned at 12:30 P.M.
