In opening the meeting the President extended a special word of welcome to Medical Directors present at the meeting. He next introduced Maurice C. Polman of London and Dr. Arthur Hunter.

The President then introduced Vice President Malvin E. Davis who presided over the informal discussion. The Society discussed informally Topics I and II. The meeting adjourned for lunch at 12:30 P.M.

The members reassembled at 2:00 P.M. The President introduced Leigh Cruess, Chairman of the Committee on Mortality under Ordinary Insurances and Annuities, who headed a panel presentation on the 1951 Impairment Study.

Upon completion of the panel presentation (digest of which will be combined in the Western Spring Meeting Number of the *Transactions* with that of a similar presentation at that meeting), the President introduced Vice President Pearce Shepherd who presided for the balance of the

afternoon during which time the Society discussed informally Topics III and IV. The meeting adjourned at 5:30 P.M.

On Friday, April 30, the President called the meeting to order at 9:30 A.M.

The minutes of the annual meeting held October 29, 30, and 31, 1953, were approved as printed in the *Transactions* of that meeting.

The President extended a welcome to the new Fellows and Associates who were attending their first meeting of the Society after attaining their present ranks.

Obituaries are printed in this number of the *Transactions*. Obituaries for Mr. John G. Parker and Mr. Alva J. McAndless, former Presidents of the predecessor organizations of the Society, were read. The Society stood for a moment in silent respect to these deceased members.

The Secretary-Treasurer presented the following summary of the business transacted by the Board of Governors since the last meeting of the Society:

1. The Board of Governors approved the report of the Committee on Mortality and Morbidity among Lives Individually Insured, which included plans for additional studies in 1954 as follows:
 - a) Individual annuity contract experience from 1948 to 1953 anniversaries.
 - b) Large amounts experience from 1948 to 1953 anniversaries.Also, plans are to be worked out for an investigation in 1955 of mortality in relation to build and blood pressure. The possibility will be explored of a double indemnity experience according to size of policy as a by-product of the contemplated build and blood pressure study.
2. The Board authorized the appointment of a committee by the President to explore the possibility of an "Executive Committee" arrangement which would make it unnecessary for much of the detail presently going to the Board of Governors to be presented at their meetings—the "Executive Committee" to also take care of various questions between Board meetings.
3. On March 31, 1954, the membership of the Society consisted of 807 Fellows and 608 Associates, making a total of 1,415 members.
