The members stood for a moment in silent respect. Obituaries are printed in this number of the *Transactions*.

The minutes of the annual meeting held October 5, 6, and 7, 1955, as printed in the *Transactions*, Volume VII, pages 568-76, were approved.

On a recommendation of the Board of Governors, transmitted previously to the Fellows of the Society, that the President of the Faculty of Actuaries, Kenneth K. Weatherhead, be admitted without examination as a Fellow of the Society of Actuaries, the Fellows present voted unanimously to approve such recommendation. The vote was taken by a show of hands, the President having previously entertained a motion that the election be held in this manner as the equivalent of the customary election by ballot. The President was directed to forward a cablegram to Mr. Weatherhead advising him of his admission.

The Secretary-Treasurer presented the following summary of the business transacted by the Board of Governors since the last meeting of the Society:

1. The Board received a report from the Committee on Mortality and Morbidity among Lives Individually Insured stating that statistics are being gathered to make up a mortality experience on settlement options and deferred annuities covering the last five years.
The Board authorized the Committee to proceed with a Double Indemnity study.
2. The Society has arranged for a gift to be presented to the Faculty of Actuaries at the occasion of their Centenary in June 1956. The gift consists of a Presidential chair and two side chairs.
3. In accordance with the authorization of the Board the President has appointed a special committee to review the organization and procedures of the Society, under the chairmanship of D. N. Warters.
Also on the recommendation of the Board the President has appointed a Public Relations Committee under the chairmanship of Pearce Shepherd.
4. The Board received the final report of the Special Library Committee. The Board authorized the destruction of certain publications which have no apparent interest to the Society or to the various colleges. A list of the books to be destroyed is on file in the Society office. The committee was discharged.
5. The Board took the following action with respect to subsequent Society meetings:
 - a) Fall Meeting 1958 at Netherland Plaza Hotel, Cincinnati, Ohio:
The date of the meeting was changed to October 2, 3 and 4.

- b) 1959: Approval of Eastern Spring Meeting, March 19 and 20, Hotel Commodore, New York.
Approval of Western Spring Meeting, June 11 and 12, Mark Hopkins and Fairmont Hotels, San Francisco.
6. As of March 15, 1956 the membership of the Society consisted of 889 Fellows and 681 Associates, making a total of 1,570 members.

The Society next discussed informally Topic I with Vice-President M. E. Davis presiding. The meeting adjourned for lunch at 12:30 P.M.

The afternoon session was called to order at 2:00 P.M. by Mr. M. E. Davis. Topics II and III were discussed informally. The afternoon session adjourned at 4:50 P.M. At 6:00 P.M. the Hartford companies were hosts at a reception.

On Friday, April 20, the meeting was called to order by Vice-President C. A. Spoerl at 9:30 A.M. Topics IV and V were discussed informally.

On behalf of the Society Mr. R. A. Hohaus expressed appreciation to the Hartford companies for their generous hospitality.

The President adjourned the meeting at 12:20 P.M.
