Robert L. Brown has been elected SOA president-elect for 1999-2000. Brown is a Fellow of the Society and of the Canadian Institute of Actuaries (CIA) and an Associate of the Casualty Actuarial Society, and he was 1990-91 CIA president. He is a professor in the Department of Statistics and Actuarial Science, University of Waterloo, Waterloo, Ontario, and also is a consultant in private practice.

Brown will take office Oct. 20 during the SOA annual meeting, Oct. 17-20, San Francisco. His term as SOA president will begin the following

October.

Brown was a 1992-95 member of the SOA Board of Governors and a 1997-99 vice president. He has also served on numerous SOA committees, including those on actuarial education and examinations, technology, and social insurance.

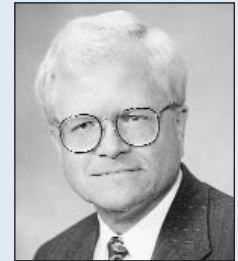

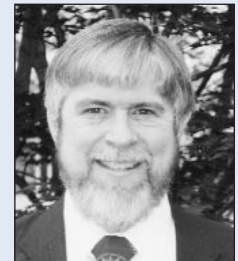

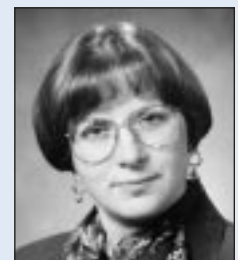
