The President welcomed the members of the Canadian Association of Actuaries and thanked the Canadian actuaries for their assistance in preparing the program. He thanked the Toronto insurance companies and consulting actuaries for the reception given by them to which the members had been invited.

The President introduced Miss C. C. Naeff, of The Hague, Holland, and Mr. D. Flach, of Munich, Germany, to the members.

The President announced that notice of the death of Stefan Hansen and George B. Buck, Fellows of the Society, had been received since the last meeting of the Society. The members stood a moment in silence out of respect for these men. The obituaries for these members are printed in this number of the *Transactions*.

The Minutes of the Annual Meeting held September 28, 29 and 30, 1960, as printed in the *Transactions*, Volume XII, pages 869-879, were approved.

The Secretary presented the following summary of the business transacted by the Board of Governors since the last meeting:

1. The Board of Governors approved a plan for the transfer of the library of the Society to the care of the Insurance Society of New York. The library will remain the property of the Society but would be administered by the professional staff of the Library of the Insurance Society of New York. Fellows and Associates will have access to the books of the Library of the Insurance Society in addition to those owned by the Society of Actuaries.
2. The Committee for the Preparation of Monetary Tables reported that Volumes I, II and III of the *1958 CSO Tables* have been distributed and that Volume IV will be delivered shortly. The cost of the publication of the Tables was more than covered by the sale of the volumes at the prepublication price. Preparation of the volumes covering values for total disability and accidental death benefits is going forward.
3. The Committee to Study Possible Usefulness of Outside Sources of

Medical Impairments has completed arrangements with the Mortality Committee of the Association of Life Insurance Medical Directors for a follow-up study of a large number of persons admitted to VA Hospitals for coronary disease and peptic ulcers.

4. The Board of Governors requested the Committee for the Preparation of Monetary Tables to study the question of the advisability of preparing monetary tables based on the 1958 CSO Mortality Tables and on age last birthday.
5. The Board of Governors approved the application of Zbigniew Jarkiewicz, a Fellow of the Institute of Actuaries, for Associateship with waiver of examinations.

The meeting then proceeded to the presentation and discussion of the papers as printed in this number of the *Transactions*.

The President extended a welcome to the new Associates who were attending their first meeting after attaining their present rank.

The membership then proceeded to the informal discussion of Topic I with Vice-President Milliman as chairman. The meeting adjourned for lunch at 12:30 P.M.

The membership reassembled at 2:00 P.M. in two separate groups. One session on Ordinary Insurance Problems was presided over by George Ryrie as Chairman while the second on Employee Benefit Plans had Hugh McLeod as Chairman. These meetings adjourned at approximately 4:30 P.M.

At 9:30 A.M., Friday, June 2, 1961, the meeting reassembled. President Warters opened the session by thanking all those who had taken part in the program. The membership then proceeded to the informal discussion of Topics II, III, IV and V under the alternate chairmanship of Vice-Presidents Henningsen and Milliman. The meeting adjourned at 12:30 P.M.

The Smaller Company Forum was called to order by Chairman James Hunter at 2:00 P.M. and proceeded to the discussion of the topics on its program.

The meeting adjourned at 4:15 P.M.
