The President introduced as distinguished guests Dr. Karl Borch, of Princeton University, Princeton, New Jersey; Mr. Gunnar Benktander,

of the Swedish Atlas Reinsurance Co., Ltd., Stockholm, Sweden; Mr. Jean M. Lindberg, of the Chase Manhattan Bank, New York, New York; and Mr. Norman C. Turner, of J. Sainsbury, Ltd., London, England.

The President advised that the Society had received word of the deaths of five members since the last meeting: William J. Graham, Gunter P. Jahn, and Sherman Crary Kattell, Fellows; Clifton L. Hickok and William Leslie, Associates. The members stood for a moment in silent respect. Obituaries are printed elsewhere in this number of the *Transactions*.

The minutes of the regional spring meeting held May 24 and 25, 1962, as printed in the *Transactions*, Volume XIV, pages 315-18 inclusive, were approved with the insertion of the following paragraph concluding the minutes on page 318: "A Smaller Company Forum was called to order at 2:00 P.M. on Friday, presided over by Mr. Hubert M. Stiles. After discussion of the questions in the program, this session adjourned at approximately 4:30 P.M."

The minutes of the regional spring meeting held June 7 and 8, 1962, as printed in the *Transactions*, Volume XIV, pages 319-25 inclusive, were approved.

Mr. Henry Rood, Chairman of the Committee on Organization and Procedure, gave a report on the recommendations of the Committee which were being presented to the Board of Governors. He discussed the background of investigations made by the Committee leading up to a recommendation for an increase in members' dues.

The Secretary presented the following summary of the business transacted by the Board of Governors since the last meeting of the Society:

1. The Board of Governors voted to set the associateship level under the new examination syllabus at the completion of the first five examinations.
2. The Board of Governors authorized the President to appoint one or more members of the Society to serve on a Joint Committee on Organization of the Actuarial Profession. The Casualty Actuarial Society, the Conference of Actuaries in Public Practice, and the Fraternal Actuarial Association are also being asked to make similar appointments, and a representative of the Canadian Association of Actuaries will participate in the deliberations. Its purpose is to explore the means of obtaining legal accreditation of actuaries in the United States, including the development of plans for creating a national association of actuaries, membership in which would constitute qualification for such accreditation. The proposals developed by this Joint Committee will be referred back to the Board of Governors for appropriate action.
3. The Board of Governors voted to accept a recommendation by the

Committee on Organization and Procedure that Society dues be increased, subject to the approval of an appropriate amendment to the By-Laws by the Board at the next Board meeting. The proposed dues schedule is as follows:

	Dues
Fellows .....	\$40
Associates paying dues for five years or more .....	40
Associates paying dues for less than five years.....	20
Members not residing in the United States or Canada..	20

It is anticipated that this increase will be reflected in the dues notice to be mailed in June of this year. This increase is necessary to cover an estimated \$15,000-\$20,000 annual deficit that would occur under the Society's present dues structure.

The Board also voted to accept the Committee on Organization and Procedure's recommendation to increase the meeting registration fee for nonmembers to \$15.

4. The Board of Governors voted to accept the recommendation of the Committee on Organization and Procedure that the Program Committee arrange a reception or other social affair at most Society meetings.
5. The Board of Governors voted to waive associateship examinations for the following Fellows of the Institute of Actuaries: Donald T. Fabian, Keith J. Harding, and Richard J. Squires.
6. The Board of Governors voted to accept the recommendation of the Executive Committee that a regional meeting of the Society be held at the Denver Hilton Hotel, in Denver, Colorado, on April 22 and 23, 1965. At a previous meeting of the Board, it had been voted to hold other regional meetings of the Society in 1965 as follows:

The meeting then proceeded to the presentation and discussion of formal papers as printed in this number of the *Transactions*.

A welcome was extended to the new Fellows and Associates who were attending the first meeting of the Society since attaining their present rank.

The meeting adjourned for lunch at approximately 12:30 P.M.

The meeting reassembled at 2:00 P.M. in two sessions for informal discussion of topics of special interest, with Mr. Richard H. Morse presiding at the session on Health Insurance, and Mr. Irving Rosenthal pre-

siding at the session on Retirement Plans. These meetings adjourned at approximately 4:30 P.M.

On Friday, March 29, the meeting was called to order at 9:30 A.M. by President Miller. The President introduced Mr. Laurence Longley-Cook, president of the Casualty Actuarial Society. Mr. Longley-Cook conveyed his greetings to the members attending.

The meeting then proceeded to the topics of general interest. Vice-President Fitzhugh presided over the discussion of Topics 1, 2, and 3. Mr. Edwin B. Lancaster, General Chairman of the Education and Examination Committee, and Mr. Bert A. Winter, Chairman of the Advisory Committee on Education and Examination, gave background reports on the revised examination syllabus. Vice-President November presided over the discussion of Topics 4, 5, and 6.

President Miller closed the session, after thanking all those who had presented papers and who had taken part in the discussion and preparation of the program. The meeting adjourned at 12:30 P.M.

The Smaller Company Forum was called to order at 2:00 P.M. on Friday, presided over by Mr. James G. Bruce. After discussion of the questions in the program, this session adjourned at approximately 4:30 P.M.
