# Capital site for annual meeting

Society members attending the annual meeting on October 25-28, just one week before the Presidential election, will have a front-row seat in the center of the U.S. government — Washington, D.C. As members attend sessions at the Washington Hilton & Towers on "Financial Security Systems in the 21st Century," campaigns will be getting down to the wire. Each candidate will be promoting his party's plan for health care, retirement funding, and other economic issues, all affecting how actuaries practice their profession into the 21st century.

The keynote speaker. John Naisbitt, co-author of the 1990 best-seller *Megatrends 2000*, looks optimistically into the next century, speaking on "The New World Order." He will discuss his belief that a New World Order composed of the Group of Seven — United States, Britain, Germany, Japan, France, Italy, and Canada — is replacing the former two superpowers.

Naisbitt will address other aspects of the New World Order that include the 10 new directions for the 1990s he and Patricia Aburdene wrote about in Megatrends 2000:

- Global economic boom, free of any past limits known before the integration of world economies
- Renaissance in the arts, with theaters, museums, and opera replacing sports as society's dominant leisure activity
- Emergence of free market socialism
- Intermingling of cultures and growth of cultural nationalism
- Privatization of the welfare state
- · Rise of the Pacific Rim
- · Decade of women in leadership
- Promise and dangers from rapid advances in biotechnology
- Religious revival
- Triumph of the individual over the collective

After the keynote address, another general session on "Management Response" will feature corporate chief executives discussing how financial securities businesses can be proactive today as they make plans to guide their companies into the 21st century.

While in the nation's capital, participants and their spouses can enjoy tours of famous monuments, government buildings, Mount Vernon, and Hillwood, the Post mansion.
