FINANCIAL MODELING OF PENSIONS AND OTHER LIFE INCOME BENEFITS

August 28-30, 1980

The Fifteenth Actuarial Research Conference is sponsored by the Society of Actuaries Committee on Research and the Department of Insurance of The Pennsylvania State University. Anyone with an interest in financial modeling as applied to pensions and other life income benefits is welcome. Advance registration may be completed by returning the lower part of this announcement. Registration is also possible at the Conference.

Scope: The emphasis of the conference will be on the dynamics, projection and probabilistic modeling of both the assets and liabilities of pension plans and other life income benefits, and the role of mathematics statistics and economics in the study of such matters. Topics such as sampling, including stratification and error control, indexing and immunization, as they relate to pensions and other life income benefits, are within the scope of the conference.

Transportation: Penn State's University Park Campus is located on routes 26 and 322 in the town of State College. Route 26 connects with Interstate 80 nearby. Philadelphia, Pittsburgh, Washington, and New York are approximately four hours by car. The State College area and Penn State University Park Campus are serviced by two airports: State College/Bellefonte Airport located five miles from campus, and the Mid-State Airport located twenty-five miles from campus. Round-trip commuter flights connect through Pittsburgh, Philadelphia, Washington, and Baltimore. Enrollees may request local travel agents to contact Allegheny Airlines (USAir) or Air-Atlantic Airlines for current flight schedules and air fares.

Lodging: A limited number of rooms have been blocked at the Sheraton Penn State Inn for participants in this conference, and will be held until August 14. Rates are \$27 and \$33 per night for one and two persons respectively.
