- a) More emphasis will be given to the formal reviews covering subjects of particular interest to the actuarial profession.
 - b) Articles in foreign periodicals will not be listed unless they are outstanding articles of considerable interest to the members of the Society.
 - c) Listings of books on Pensions and Social Insurance will be limited to outstanding books on these subjects which are of particular interest to actuaries.
3. The Committee on Disability and Double Indemnity reported that the intercompany study of disability covering the period 1930-1950 will be released to the Editor for inclusion in the 1952 Committee Reports.
 4. Advance subscriptions to the Society's publications *Annuity Table for 1949* and *Life Contingencies* have been sufficient to defray the cost of publication of these two books.
 5. The Board adopted a resolution providing that all unwritten discussion will be reported by the stenotypist. If a speaker prefers to have part of his remarks not reported by the press nor included in the *Transactions* he may indicate that it is not for publication.
 6. The Board of Governors considered the method of requesting companies to contribute to the cost of preparing and publishing the various committee reports. The Board felt that the method used for the 1951 Committee Reports was satisfactory and authorized its continuance. It was felt that the companies receiving the results of these investigations were obtaining valuable material at a nominal cost.
 7. On September 30, 1952, the membership of the Society consisted of 784 Fellows and 559 Associates, making a total of 1,343 members.

The President delivered his presidential address as printed in this number of the *Transactions*.

The President introduced Mr. L. G. Oxby and Mr. H. F. Bell from Australia, and Mr. Manuel Gorman of the Life Insurance Association of America. He also introduced Messrs. Eugene A. Rasor and Thomas C. Smith, who were co-authors of papers presented at the meeting.

The minutes of the spring meetings held April 24 and 25, 1952, and June 5 and 6, 1952, were approved as printed in the *Transactions* for those meetings.

The President announced the death of four Fellows, Arthur Griswold, Arthur J. Koeppe, George J. Lidstone, and Arthur B. Wood.

The Secretary-Treasurer summarized the business transacted by the Board of Governors as follows:

1. The Education and Examination Committee reported that it was studying the inclusion of Sickness and Accident Insurance in the Syllabus for examinations and that it was likely that this subject would be included in the Syllabus for 1954.
2. The Board of Governors approved the recommendations of the Committee on Review and agreed that the policy of the Society with respect to reviews should be as follows:
