## Society of Actuaries' "Get Powered Up!" Sweepstakes

## **Official Rules**

## NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. ELIGIBILITY: Society of Actuaries' "Get Powered Up!" ("Sweepstake") is open only to legal residents of fifty (50) states of the United States, Puerto Rico, the District of Columbia and Canada (void in Quebec) who are at least eighteen (18) years of age or the age of majority as of October 26, 2020 who are SOA members (either Associates (ASA) or Fellows (FSA)) or active candidates (an "active candidate" is an individual who has sat for an SOA examination or completed eLearning module within two (2) years of the date the Sweepstake Period). All employees of Society of Actuaries ("Sponsor"), their contractors or agents (all of the foregoing, together with Sponsor collectively, "Sweepstake Entities"), and their immediate family members and those with whom they are domiciled are ineligible to enter or win the Sweepstake. All applicable federal, state, provincial and local laws and regulations apply. Void where prohibited by law. Entry in the Sweepstake constitutes your full and unconditional acceptance of these official rules ("Official Rules").

2. SWEEPSTAKE PERIOD: The Sweepstake entry period begins at 12:00:01 AM CDT on October 26, 2020 and ends at 11:59:59 PM Central Standard Time on November 23, 2020 (the "Sweepstake Period"). The winner will be selected from entries properly submitted to the Sweepstake.

3. SWEEPSTAKE ENTRY INSTRUCTIONS: There is one (1) way to enter this Sweepstake: by signing up for SOA's "Exponential Opportunities" newsletter. Limit one (1) entry per person. Any attempts by an entrant to submit more than one (1) entry into this Sweepstake will result in such subsequent entries being disqualified.

4. SELECTION OF SWEEPSTAKE WINNERS: Thirty (30) potential Prize Winners will be selected in a random drawing to be held on or before November 27, 2020. The potential Prize Winners will be selected from all eligible entries received during the Sweepstake Period. The potential Prize Winners will be notified on or before November 27, 2020. If one or more of the selected potential Prize Winners is a Canadian resident, that person must also answer correctly, within a 5 minute time period, a mathematical skill-testing question without the benefit of any human, mechanical or electronic calculating devices before the prize will be awarded. Odds of winning will depend on the number of eligible

entries received during the Sweepstake Period. The Sweepstake will be conducted by Sponsor, the judge of the Sweepstake, whose decisions on all matters relating to the Sweepstake shall be final and binding. At the sole discretion of Sponsor, disqualification, forfeiture and the selection of an alternate winner may result from any of the following: (1) a potential Prize Winner's failure to respond to notification promptly after its transmission;

(2) the return of an email notification as undeliverable after three (3) attempts; (3) a potential Prize Winner's failure to provide Sponsor with satisfactory proof of age, identity and residency; (4) a Canadian potential Prize Winner's failure to correctly answer within the time period the mathematical skill-testing question; (5) any other non-compliance with the Official Rules.

5. PRIZE: Three (3) Prizes will be awarded in this Sweepstake. Each Prize consists of a "Power Pack" which includes an SOA branded charger, hat and a tumbler. The actual retail value of the prize is \$50.00 USD. The Sponsor will ship the Prizes to the Winners at its expense. reserves the right at its sole discretion to disqualify the Entry of any individual found to be (a) tampering or attempting to tamper with the entry process or the operation of the Sweepstake or (b) violating these Official Rules or the terms of service, conditions of use, and/or general rules of any Sponsor property or service.
