The Society of Actuaries (SOA) Research Division is holding their annual Student Research Case Study Challenge, which provides an opportunity for teams of students to apply their actuarial skills to a real-world problem. The challenge is just one part of SOA's larger focus on advancing education and research for the actuarial profession.

ABOUT THE CHALLENGE

This nine-week international challenge sees teams of up to five students from the same college or university research a case study situation, conduct actuarial analysis, formulate solutions and present recommendations. The work requires a team approach to identify issues and organize priorities – critical skills as these budding professionals move toward their careers.

Submissions will be graded by a team of judges, and the top teams will present to the judging panel via audio and/ or video conference in April 2021. In addition to prize money and university grants for the top three teams, all teams meeting a minimum standard will be recognized on the SOA website and in official SOA publications, and team members will be awarded a certificate of participation.

SPONSOR TERMS AND CONDITIONS

All sponsors participating in the 2022 Student Case Study Challenge are subject to this agreement.

Sponsorship submission must be received by Monday, December 13, 2021 for logo to be included on materials.

All sponsorships are granted on first-come basis unless an agreement is made for first right of refusal for the following year. Telephone reservations will be held for three business days pending receipt of agreement and applicable fee payment. Once the Society of Actuaries (SOA) has received a signed agreement and payment, a copy signed by an SOA representative will be returned to you.

The SOA or Sponsor may terminate their obligations under these terms for cause without liability to the nonterminating party, upon written notice to the other party within five (5) business days of such occurrence or receipt of notice, for any of the following conditions: to acts of God, acts or threats of war and/or terrorism, government regulation, natural disaster, fire, earthquakes, shortages or disruptions of the electrical power supply causing blackout or reduced utilities in a city where event/program is located, nuclear hazard, strikes (but not by the employees or contractors of the party seeking to use this clause), labor disputes, civil disorder, curtailment of transportation facilities on which event/ program attendees would be expected to rely, public health warnings made by the World Health Organization, Centers for Disease Control and Prevention or National Institutes of Health, or any other public health organization, agency or official, or any other emergency of a comparable nature beyond the parties' control, making it impossible, illegal or commercially impracticable or inadvisable for either party to perform its obligations under these terms. The party seeking cancellation of performance under this provision must exercise due diligence and take all reasonable steps to avoid, remove and overcome the effects of the force majeure event. SOA reserves the right to either cancel the event or reschedule it for a different date and/or location. Should the event/program be rescheduled for a different date, Sponsor may make the election to receive a refund for the fees collected by the SOA or transfer the fees to a sponsorship for the new event/program date. In the case of cancellation, the SOA shall have no further liability to you other than refund your fees. It will not be responsible to you for any other resulting costs or liabilities incurred by you as a result of the cancellation.

If SOA cancels the event/program for any reason apart from those covered above, partner will be refunded within 30 days for any payments already made.

If Sponsor requests cancellation, request must be submitted in a written format. Cancellations will be handled on a case by case basis. All cancellations will be less a \$500 administrative fee and a prorated amount based on time of cancellation.
