Each week of the contest, a new puzzle will be posted. The contest is progressive meaning the solution from the previous week will help you solve the problem for the next week.

Completed and correct entries for all three weeks will be entered in a random drawing for the following prizes.

Winners will be announced on SOA.org, SOA News Weekly e-mail newsletter and on SOA social media channels with permission.

Judging Criteria

The judges, members of the SOA Young Professional Advisory Council, will review each entry for the accurate answer. The judges reserve the right not to award prizes if they determine that no puzzle submission is qualified.

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. ELIGIBILITY: Society of Actuaries' (SOA) Young Professional Advisory Council's Ask an Actuary Puzzler Contest ("Sweepstake") is open only to legal residents of fifty (50) states of the United States and the District of Columbia and Canada (void in Puerto Rico, all U.S. territories and possessions, all U.S. overseas military installations, and void in Quebec) who are at least eighteen (18) years of age or older as of December 28, 2020, or the legal age of majority, who are candidates or members of the SOA on the day the first puzzle is released. SWEEPSTAKE PERIOD: The Sweepstake entry period begins at 8:00 AM CDT on December 28, 2020, and submissions for each week's puzzle ends at 11:59 PM CDT on the following dates: January 3, 2021; January 10, 2021; and January 17, 2021 (the "Sweepstake Periods"). The winners will be selected from entries properly submitted using the puzzle form provided on SOA.org.
- 3. SWEEPSTAKE ENTRY INSTRUCTIONS: There is one (1) way to enter this Sweepstake: by completing the puzzle and providing the correct answer using the provided Puzzle Form from the webpage. Also providing a name and email address at the end of the Puzzle Form to be entered into the Sweepstakes for each week's puzzle. A new puzzle will be posted each week for three weeks. The answer from the previous week may help solve the problem from the

current week's puzzle. Limit one (1) entry per person, per week's puzzle during the Sweepstake Periods. Any attempts by an entrant to submit more than one (1) entry into this Sweepstake will result in such subsequent entries being disqualified.

4. SELECTION OF SWEEPSTAKE WINNERS: Three (3) potential Prize Winners will be selected in a random drawing to be held on or before February 16, 2021. The potential Prize Winners will be selected from all eligible entries received during the Sweepstake Period. If any of the selected potential Prize Winners are a Canadian resident, that person must also answer correctly, within a 5-minute time period, a mathematical skill-testing question without the benefit of any human, mechanical or electronic calculating devices before the prize will be awarded. Odds of winning will depend on the number of eligible entries received during the Sweepstake Period. The potential Prize Winners will be notified via the e-mail address provided by that Winner at Sweepstake entry within two (2) weeks after the Sweepstake Prize Winner is selected ("Prize Award Period"). The Sweepstake will be conducted by Sponsor, the judge of the Sweepstake, whose decisions on all matters relating to the Sweepstake shall be final and binding.
