**\*\*\*Candidates that receive a passing grade on the July 14<sup>th</sup> grade release and become eligible for the FAC will be allowed to attend the August FAC. You will receive your invitation the following week and will be given one week to register. The deadline will only be pushed back for candidates fitting this criteria.**

Candidates will receive registration materials for the next available FAC via email after they have successfully completed all requirements for Fellowship. Note that the invitation emails will be sent out approximately once every 2 weeks. When a FAC deadline is approaching invitations will be sent with more frequency. You will not miss an invitation if you eligible for a specific FAC due to any timing issues with the invitations. All DMAC and FSA module submissions received by the deadline will be graded in time to qualify for the FAC as long as the project meets minimum requirements. Even if the modules cannot be graded by the registration deadline you will be able to register for the FAC. The SOA will push back the registration cutoff date as long as your submission was received prior to the deadline.

Note that candidates must have also completed all other requirements for Fellowship to receive an invitation to register for the FAC. Submissions received after the deadline may or may not be graded in time, depending on queue size, grader availability, etc. Likewise, submissions which are received by the deadline but do not meet the minimum requirements and require revisions and resubmission will be placed at the end of the queue and may not be graded in time. Candidates are instructed that they must allow up to eight weeks for the grading of their FSA modules and/or DMAC project; more time may be required if multiple graders are necessary.
