Society of Actuaries "2017 Annual Meeting & Exhibit Evaluation Raffle" Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. ELIGIBILITY: Society of Actuaries' "2017 Annual Meeting & Exhibit Evaluation Raffle" ("Sweepstake") is open only to legal residents of fifty (50) states of the United States and the District of Columbia and Canada (void in Puerto Rico, all U.S. territories and possessions, all U.S. overseas military installations, and void in Quebec) who are at least eighteen (18) years of age or older as of October 16, 2017, who are registered attendees the SOA Annual Meeting & Exhibit in Boston, MA. All employees of Society of Actuaries ("Sponsor"), exhibitors, or sponsors, or any of their contractors or agents (all of the foregoing, together with Sponsor collectively, "Sweepstake Entities"), and their immediate family members are ineligible to enter or win the Sweepstake. - 2. SWEEPSTAKE PERIOD: The Sweepstake entry period begins at 7:00 AM EDT on October 16, 2017, and ends at 1:00 PM EDT on October 30, 2017 (the "Sweepstake Period"). The winner will be selected from entries properly submitted to the Sweepstake.
- 3. SWEEPSTAKE ENTRY INSTRUCTIONS: There are two (2) way to enter this Sweepstake: by completing and submitting a meeting survey and evaluation form following the close of the final session at the SOA Annual Meeting & Exhibit in Boston, MA either 1) online via an emailed link or 2) through the Annual Meeting & Exhibit mobile application. One (1) entry per person; any attempts by an entrant to submit more than one (1) entry into this Sweepstake will result in such entrant being disqualified.
- 4. SELECTION OF SWEEPSTAKE WINNERS: Three (3) potential Prize Winners, one (1) First Place Prize Winner, one (1) Second Place Prize Winner, and one (1) Third Place Prize Winner, will be selected in a random drawing to be held on or before November 6, 2017. The potential Prize Winners will be selected from all eligible entries received during the Sweepstake Period. The potential Prize Winners will be notified on November 6, 2017. If one or more of the selected potential Prize Winners is a Canadian resident, that person must also answer correctly, within a 5 minute time period, a mathematical skill-testing question without the benefit of any human, mechanical or electronic calculating devices before the prize will be awarded.
