<b>2. Topic: Risk Modeling and Aggregation of Risks</b>
<b>Learning Objectives</b>
The candidate will understand the concepts of risk modeling and be able to evaluate and understand the importance of risk models.
<b>Learning Outcomes</b>
The candidate will be able to: <ul style="list-style-type: none"><li>a) Demonstrate how each of the financial and non-financial risks faced by an entity can be amenable to quantitative analysis including an explanation of the advantages and disadvantages of various techniques such as Value at Risk (VaR), stochastic analysis, and scenario analysis.</li><li>b) Evaluate how risks are correlated, and give examples of risks that are positively correlated and risks that are negatively correlated.</li><li>c) Analyze and evaluate risk aggregation techniques, including use of correlation, integrated risk distributions and copulas.</li><li>d) Apply and analyze scenario and stress testing in the risk measurement process.</li><li>e) Evaluate the theory and applications of extreme value theory in the measuring and modeling of risk.</li><li>f) Analyze the importance of tails of distributions, tail correlations, and low frequency / high severity events.</li><li>g) Analyze and evaluate model and parameter risk.</li><li>h) Construct approaches to modeling various risks and evaluate how an entity makes decisions about techniques to model, measure and aggregate risks including but not limited to stochastic processes.</li></ul>

<b>3. Topic: Risk Measures</b>
<b>Learning Objectives</b>
The candidate will understand how the risks faced by an entity can be quantified and the use of metrics to measure risk.
<b>Learning Outcomes</b>
The candidate will be able to: <ul style="list-style-type: none"><li>a) Apply and construct risk metrics to quantify major types of risk exposure such as market risk, credit risk, liquidity risk, operational risk, regulatory risk, etc., and tolerances in the context of an integrated risk management process.</li><li>b) Analyze and evaluate the properties of risk measures (e.g., Delta, volatility, duration, VaR, TVaR, etc.) and their limitations.</li><li>c) Analyze quantitative financial market data and insurance data (including asset prices, credit spreads and defaults, interest rates, incidence, causes and losses) using modern statistical methods. Construct measures from the data and contrast the methods with respect to scope, coverage and application.</li><li>d) Analyze risks that are not easily quantifiable, such as operational and liquidity risks.</li></ul>

<b>4. Topic: Risk Management Tools and Techniques</b>
<b>Learning Objectives</b>
The candidate will understand the approaches for managing risks and how an entity makes decisions about appropriate techniques.
<b>Learning Outcomes</b>
The candidate will be able to: <ul style="list-style-type: none"><li>a) Demonstrate and analyze applicability of risk optimization techniques and the impact of an ERM strategy on an organization's value. Analyze the risk and return trade-offs that result from changes in the organization's risk profile.</li><li>b) Demonstrate means for transferring risk to a third party, and estimate the costs and benefits of doing so.</li><li>c) Demonstrate means for reducing risk without transferring it.</li><li>d) Demonstrate how derivatives, synthetic securities, and financial contracting may be used to reduce risk or to assign it to the party most able to bear it.</li><li>e) Develop an appropriate choice of a risk mitigation strategy for a given situation (e.g., reinsurance, derivatives, financial contracting), which balances benefits with inherent costs, including exposure to credit risk, basis risk, moral hazard and other risks.</li><li>f) Analyze the practicalities of market risk hedging, including dynamic hedging.</li><li>g) Demonstrate the use of tools and techniques for analyzing and managing credit and counterparty risk.</li><li>h) Analyze funding and portfolio management strategies to control equity and interest rate risk, including key rate risks. Contrast the various risk measures and be able to apply these risk measures to various entities. Explain the concepts of immunization including modern refinements and practical limitations.</li><li>i) Analyze the application of Asset Liability Management and Liability Driven Investment principles to Investment Policy and Asset Allocation.</li><li>j) Demonstrate risk management strategies for other key risks (for example, operational, strategic, legal, and insurance risks).</li><li>k) Apply best practices in risk measurement, modeling and management of various financial and non-financial risks faced by an entity.</li></ul>

<b>5. Topic: Capital Management</b>
<b>Learning Objectives</b>
The candidate will understand the concept of economic capital, risk measures in capital assessment and techniques to allocate the cost of risks within business units.
<b>Learning Outcomes</b>
The candidate will be able to: <ul style="list-style-type: none"><li>a) Describe the concepts of measures of value and capital requirements (for example, EVA, embedded value, economic capital, regulatory measures, and accounting measures) and demonstrate their uses in the risk management and corporate decision-making processes.</li><li>b) Define the basic elements and explain the uses of economic capital. Explain the challenges and limits of economic capital calculations and explain how economic capital may differ from external requirements of rating agencies and regulators.</li><li>c) Apply risk measures and demonstrate how to use them in capital assessment. Contrast regulatory, accounting, statutory and economic capital.</li><li>d) Propose techniques for allocating /appropriating the cost of risks/capital/hedge strategy to business units in order to gauge performance (risk adjusted performance measures).</li><li>e) Demonstrate the ability to develop a capital model for a representative financial firm.</li></ul>
