The SOA is tentatively planning to offer an in-person option for FAC139 on December 6-7 at the Chateau Elan in Braselton, GA. All candidates registering for FAC139 will be required to complete the FAC e-Learning module and related assignments by the scheduled deadlines, followed by either a virtual session or participation at the 2-day in-person FAC on Dec 6-7. The in-person FAC component will have a limited capacity and be available on a first-come first-served basis. It will include the traditional FAC celebratory banquet. Information on covid-19 related guidelines will be posted here at a later date.

The registration fee for all 2021 FACs is \$2150. Candidates will receive registration materials for the next available FAC via email after they have successfully completed all requirements for Fellowship. Note that the invitation emails will be sent out approximately every 2-3 weeks. When a FAC deadline is approaching invitations will be sent with more frequency. All DMAC and FSA module submissions received by the deadline will be graded in time to qualify for the FAC should the project(s) meet minimum requirements. Submissions received after the deadline may or may not be graded in time, depending on queue size, grader availability, etc. Likewise, submissions which are received by the deadline but do not meet the minimum requirements and require revisions and resubmission will be placed at the end of the queue and may not be graded in time.

Note that candidates must have passing scores for all requirements for Fellowship to receive an invitation to register for the FAC. Candidates are instructed that they must allow up to eight weeks for the grading of their FSA modules and/or DMAC project; more time may be required if multiple graders are necessary.
