Society of Actuaries' Enhance Your Profile Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. ELIGIBILITY: Society of Actuaries' "Enhance Your Profile Sweepstakes" ("Sweepstake") is open only to legal residents of fifty (50) states of the United States, Puerto Rico, the District of Columbia, Canada, and China (void in all U.S. territories and possessions, all U.S. overseas military installations, void in Quebec and Hong Kong) who are at least eighteen (18) years of age or the age of majority as of October 16, 2019 who are SOA members (either Associates (ASA) or Fellows (FSA)) or active candidates (an "active candidate" is an individual who has sat for an SOA examination or completed eLearning module within two (2) years of the date the Sweepstake Period). All employees of Society of Actuaries ("Sponsor"), their contractors or agents (all of the foregoing, together with Sponsor collectively, "Sweepstake Entities"), and their immediate family members and those with whom they are domiciled are ineligible to enter or win the Sweepstake. - 2. SWEEPSTAKE PERIOD: The Sweepstake entry period begins at 12:00:01 AM CDT on October 16, 2019 and ends at 11:59:59 PM Central Standard Time on December 15, 2019 (the "Sweepstake Period"). The winner will be selected from entries properly submitted to the Sweepstake.
- 3. SWEEPSTAKE ENTRY INSTRUCTIONS: There is one (1) way to enter this Sweepstake: by updating at least one (1) field in the Name and Demographics section in your My SOA account. Entry into the Sweepstake does not require that all fields provide personal information; Entrant may update fields with "Prefer not to provide." Any eligible individual who has provided personal information for at least one of the following fields, Gender, Country of Residency, Country of Origin, Current Income Range, Written Language Fluency, Race/Ethnicity, Education Information, Employment Information, by the close of the Sweepstake Period will be entered into the Sweepstake (including eligible individuals who previously provided personal information in the Name and Demographics section of their MySOA account). One (1) entry per person.
- 4. SELECTION OF SWEEPSTAKE WINNERS: Three (3) potential Prize Winners will be selected in a random drawing to be held on or before December 31, 2019. The potential Prize Winners will be selected from all eligible entries received during the Sweepstake Period. The potential Prize Winners will be notified on or before January 10, 2020. If one or more of the selected potential Prize Winners is a Canadian resident, that person must also answer correctly, within a 5 minute time period, a mathematical skill-testing question without the benefit of any human, mechanical or electronic calculating devices before the prize will be awarded. Odds of winning will depend on the number of eligible entries received during the Sweepstake Period. The Sweepstake will be conducted by Sponsor, the judge of the Sweepstake, whose decisions on all matters relating to the Sweepstake shall be final and binding.
