2018 SOA Annual Meeting & Exhibit Grand Prize Drawing Official Rules

- 1. ELIGIBILITY: The 2018 SOA Annual Meeting & Exhibit Prize Drawing ("Drawing") is open only to legal residents of fifty (50) states of the United States and the District of Columbia and Canada (void in all U.S. territories and possessions, all U.S. overseas military installations, and void in Quebec) who are at least eighteen (18) years of age or older as of October 14, 2018, who complete a registration form as described below. - 4. SELECTION OF DRAWING WINNERS: One (1) potential Prize Winner will be selected in a random drawing to be held on October 16, 2018 at 6:00 PM CDT.
