## 2018 SOA Annual Meeting "Scratch and Win Game" Sweepstake

## Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. ELIGIBILITY: Society of Actuaries' (SOA) 2018 Annual Meeting "Scratch and Win Game" Sweepstake ("Sweepstake") is open only to legal residents of fifty (50) states of the United States and the District of Columbia and Canada (void in all U.S. territories and possessions, all U.S. overseas military installations, and void in Quebec) who are at least eighteen (18) years of age or older as of October 14, 2018, or the legal age of majority. All employees of Society of Actuaries ("Sponsor"), or any of their contractors or agents (all of the foregoing, together with Sponsor collectively, "Sweepstake Entities"), and their immediate family members are ineligible to enter or win the Sweepstake. - 2. SWEEPSTAKE PERIOD: The Sweepstake entry period begins at 4:00 PM Central Daylight Time (CDT) on October 14, 2018 and ends at 5:30 PM CDT on October 16, 2018 (the "Sweepstake Period"). The winners will be selected from entries properly submitted to the Sweepstake.
- 3. SWEEPSTAKE ENTRY INSTRUCTIONS: There is one (1) way to enter this Sweepstake: by picking up a "Scratch and Win" card from the SOA booth at the 2018 Annual Meeting Exhibit Hall in Nashville, TN, USA, and scratching only one (1) circle to reveal the underlying image. If the SOA Infinity Shield image (i.e. SOA logo) is revealed, Entrant must complete the back of the scratch card and return it to the SOA booth before the close of the Sweepstakes Period. All individuals who participate in the Sweepstake will win a Participation Prize, if they return their scratch card, even if it does not reveal the Infinity Shield. Limit one (1) entry per person during the Sweepstake Period. Any attempts by an entrant to submit more than one (1) entry into this Sweepstake will result in such subsequent entries being disqualified.
- 4. SELECTION OF SWEEPSTAKE WINNERS: Participation Prize: Up to 1,000 Entrants will receive an SOA t-shirt for participating in the Sweepstakes. Three (3) potential Prize Winners will be selected in a random drawing to be held on October 16, 2018. The potential Prize Winners will be selected from all eligible entries received during the Sweepstake Period. If any of the selected potential Prize Winners are a Canadian resident, that person must also answer correctly, within a 5 minute time period, a mathematical skill-testing question without the benefit of any human, mechanical or electronic calculating devices before the prize will be awarded. Odds of winning will depend on the number of eligible entries received during the Sweepstake Period. The potential Prize Winners will be notified at the 2018 SOA Annual Meeting in Nashville, TN, USA on October 16,2018; potential Prize Winners must be present to win. The Sweepstake will be conducted by Sponsor, the judge of the Sweepstake, whose decisions on all matters relating to the Sweepstake shall be final and binding. At the sole discretion of Sponsor, disqualification, forfeiture and the selection of an alternate winner may result from any of the following: (1) a potential Prize Winner not being present at the time of the winner selection; (2) a potential Prize Winner's failure to provide Sponsor with satisfactory proof of age, identity and residency; (3) a Canadian potential Prize Winner's failure to correctly answer within the time period the mathematical skill-testing question; (4) any other non-compliance with the Official Rules.

In the event of such cancellation, termination, modification or suspension, Sponsor will select Prize Winner from all eligible, non-suspect entries received prior to such action. Sponsor also reserves the right at its sole discretion to disqualify the Entry of any individual found to be (a) tampering or attempting to tamper with the entry process or the operation of the Sweepstake or (b) violating these Official Rules or the terms of service, conditions of use, and/or general rules of any Sponsor property or service.
